GIFT AID

The Brighton Buddhist Centre is a registered charity (no. 273682) and can claim money back from the Inland Revenue on all your donations made through Giftaid. This significantly increases the value of your donation at no additional cost to yourself. For each £100 you give we can claim an additional £25 from the Inland Revenue.
